

In the coming days you will see Chattanooga Gas, or one of its trusted contractors, performing routine inspections in your neighborhood. Chattanooga Gas, along with its contractor Southeast Connections (SEC), will be inspecting underground facilities in your neighborhood.

#### **Inspect Sewers**

Sewer inspections are part of Chattanooga Gas' safety practices. If your sewer service is not accessible from the street, SEC will make contact with you to coordinate a sewer line inspection from inside your property. There will be no interruption to your natural gas or sewer service during the inspection unless repairs are needed. Vital information from the inspection will be marked on lawns and sidewalks with spray paint.



Chattanooga Gas is responsible for maintaining the underground system that safely carries reliable natural gas to homes and businesses in your area. We appreciate your patience and thank you for your understanding as we complete this important work.
